Cart Retention Plan

Pursuant to Section 4.63.035 of the Sacramento County Code, business owners must submit a Cart Retention Plan to prevent customers from removing wheeled carts from the business premises, and for retrieval of carts. This plan must be submitted to Sacramento County Code Enforcement as indicated below.

- 4) Notification of procedure to be utilized for authorized removal of cart from business premises
- 5) Notification of the unauthorized removal of cart is violation of State law and this Code.
